

I teach high school chemistry and I have one of these in my classroom. I grow Basil on it and the plants have grown wonderfully, the fish have done great and overall I have enjoyed inspiring my students to think more about the chemical reactions within the nitrogen cycle. The kids have also been really inspired to try new foods with Basil. I blended the basil with tomato paste and olive oil and used it as a spread to make grilled cheese sandwiches for my students (using my pancake griddle in the classroom). They begged all year to do it again and many of them made it at home. I also made lemon basil cookies for my students around the holidays and showed a video on the chemistry of cookies. 

Wonderful and solid aquaponics set-up!

I ordered this system because it fit onto a decently sized aquarium and had lights for the tank as well. I was also looking for a system where the fish could be enjoyed and I could have more than one. I also wanted a planted tank, so lights for the tank were important. The system is solid and was easy to set up. The components are well made. I had a little trouble locating an aquarium matching the dimensions needed for the system to fit, but eventually found one. I used a complete substrate to provide a foundation for the aquarium plant roots and put sand on top. Despite being rinsed, the sand caused significant clouding that did not clear up even after about 5 days, so I added a 5 micron felt filter to get the cloudiness to clear. I was able to remove the extra filter. I'd like to see a system to fit larger aquariums (e.g., 55 gallon tank). I'd also like to see an option for a tray top so other plants could be grown and so I could add worms in to the grow beds. I also think it would be helpful if the opening to access the aquarium was a little bigger. It is very difficult to get my arm in there. I had to do some water changes while the tank was cycling and this was a bit challenging due to the size of the opening. I have a planted tank and trying to get in to move things or put other equipment in is very difficult (I added a heater, a small log, a CO2 generator and a little cave). It is important to recognize that most of the set up in the aquarium has to be done before the top is put on. So far, I've planted kale, broccoli, cauliflower, strawberries, zucchini, watermelon, celery, tomatoes and Swiss chard. Probably a little ambitious, but everything is thriving so far!
