DISCOUNTS: Please show cash payment discount offered on your invoice in connection with any discount offered, time will be computed from date of delivery of the supplies or equipment, or from date correct invoices are received in the office specified by LRCCD if the latter date is later than the date of delivery. Payment is deemed to be made for the purpose of earning discount, on the date payment is mailed or on behalf of LRCCD.
- 4. INVOICES: Invoices shall be prepared and submitted in duplicate unless otherwise specified. GUEST SPEAKER SERIES CONSULTANT

Scope of Work September 1, 2016 – June 30, 2018.

Consultant shall assist Folsom Lake College with the design and launch of a Distinguished Speaker Series to take place at the College by providing the following services:

- 1) Conduct Programming and Market Research in the distinguished speaker field by consulting with and surveying peers (e.g., UCSB) to understand other current speaker series in California (especially on college campuses), identifying and clarifying local competition from similar series, looking for cooperative opportunities (e.g., to block book speakers with logical routing partners), communicating with booking agents to discuss FLC's interest in presenting speakers, speaker availabilities and market trends, etc. Share findings with College.
- 2) Based on environmental scan and constraining factors such as gross sales potential (resulting from Harris Center seating capacity and competitive ticket price points), provide overall thematic recommendations and feasible speaker fee bracket(s) to guide selection of speakers.
- 3) Develop a sample annual budget for an ongoing series of three presented speakers for use in long term planning.
- 4) Provide options and recommendations for a guest speaker event to take place in spring of 2017. Share these options and recommendations with a campus committee. Based on feedback from committee, and working in coordination with the Harris Center Executive Director, narrow down the list of speakers, develop a budget (with speaker fees, travel costs, projected attendance and sales), make offers and negotiate a deal for a speaker to be presented in spring 2017. Suggest/recommend ancillary events to be a part of the speaking engagement, and negotiate to have selected speaker participate in these as part of engagement deal. Have deal approved and closed by November 11, 2016 so that engagement can be included in Harris Center 2017 spring brochure.
- 5) Provide options and recommendations for speakers for a series of three distinguished speaker events to take place during the 2017/18 school year. Share these options and recommendations with a campus committee. Based on feedback from committee, and working in coordination with the Harris Center Executive Director, narrow down the list, develop a budget (with speaker fees, travel costs, projected attendance and sales), make offers and negotiate deals for three speakers. Suggest/recommend ancillary events to be a part of the speaking engagements, and negotiate to have selected speakers participate in these as part of engagement deals. Have deals approved and closed by March 31, 2017 so that series subscriptions sales can begin by April, 2017 and the engagements can be promoted in the 2017/18 Harris Center season brochure.
- 6) Meet with a designated campus committee, and with FLC staff, donors and faculty as appropriate.
- 7) Working with FLC Foundation and campus committee, strategize and help plan the range of ancillary events for above speaking engagements to leverage and maximize the positive impact of the speaker engagements on FLC instructional programs, the community and/or FLC's fund development efforts.
- 8) Provide marketing guidance for the above speaking engagements, including titles and themes for selected speakers, and a preliminary recommended marketing plan and budget for each event.
- Consult as necessary with Harris Center marketing staff to help insure the FLC Speakers Series is part of marketing materials in spring 2017, and the 2017-18 Season.
- 10) Keep Harris Center Executive Director apprised of progress made toward agreed upon objectives through regular written communications via e-mail.
